VSBE Statute

State Finance & Procurement Statutes

§14-602

- (1) the potential contracting opportunities available in the procurement contract, including both prime contracting and subcontracting opportunities, as determined through analysis of the scope of the work presented in the solicitation documents; and
 - (2) the availability of veteran-owned small business enterprises to respond competitively to the potential contracting opportunities.

Scope

C. Procurement agencies shall use the Directory as the primary resource to identify potential vendors when considering the application of a VSBE participation goal. Procurement agencies may also utilize VetBiz and any other veteran resource or database to assist in identifying potential veteran vendors.




VSBE Vendor Search For Procurement/Buyers

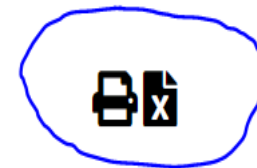




